## Statement on Modern Slavery & Human Rights

Hillbreak is unequivocal: slavery, human trafficking, child labour or any other abuse of human rights is abhorrent and has no place in our organisation or in our supply chain. This Statement confirms our approach to ensuring that we guard against unacceptable practices.

Hillbreak and APC Success, which are separate companies under common control and ownership, will not engage in bribery and this Anti-Bribery Policy applies to both equally.

However, we are committed unreservedly to the principles of responsible business and are prominent advocates within the real estate industry in this regard. Thus, we have no hesitation in stating publicly our commitment to the spirit of the Modern Slavery Act.

## Steps we are taking

Hillbreak and APC Success have several inherent characteristics which complement the specific steps we take to manage Modern Slavery risks. These include:

- we are small firms of two Directors and no direct employees; we procure the services of specialist
  professionals with high levels of professional capability and qualification to support our client advisory
  and training work;
- when engaging specialist professionals in a sub-consultancy capacity to support our client advisory and training work, this is done so under formal Contract through which the sub-contractor warrants that it is not engaged in any practice which renders it responsible for or complicit with slavery, human trafficking, child labour or any other abuse of human rights:
- all of our material suppliers and service providers\* are requested to affirm annually that their business
  and supply chains are free from slavery and all other forms of human rights abuse, with failure to provide
  such affirmation within a reasonable time period resulting in steps being taken by Hillbreak and APC
  Success to seek a change of supplier;
- when entering into any form of formal partnership with an organisation that is bound by the requirements
  of the Modern Slavery Act 2015, ensuring that it has in place relevant policies and has published an upto-date Slavery & Human Trafficking Statement;
- when providing professional services to a client organisation, we take a positive approach to agreeing to and working in accordance with their slavery and human rights policies, where we are satisfied that these are appropriate, proportionate and reasonable.
